• I'm looking into a card or fob or PIN system for the bulk water filling station. Right now, it's on the "honor system" of the haulers writing down how much water they took and how often. Sally also mentioned we've had past issues of collecting payment from a few of these guys. A programmable card/fob/PIN system would allow us to cut off their access until their accounts are paid up to date.

Meetings Schedule and Purpose: We really need to have Water/Sewer, Street, and Tree committee meetings. Many issues are hanging out in limbo right now.

Old Issues and Updates: Sidewalks, dead/dying trees, junk vehicles, commercial vehicles in residential areas – all of these ordinances still need sorted out or found. Need Zoning Inspector. Need general laborer. Need our ordinances scanned and uploaded to a searchable site.

New Issues: We really should have a leak detection survey done Village-wide on the underground water system infrastructure to show OEPA we are minimizing water loss. Price has been quoted. Trying to see whether it fits into the current budget or next year's budget.

NEEDS: so many... but I'm in the process of learning the needs that carried over from the past and the needs for the near and more distant future and prioritizing them with consideration for EPA compliance, limited staff, items not budgeted, etc.
